

Minutes of the Annual Meeting of Participating Members
Rural Water District No.5, Mayes County, Oklahoma

January 14, 2019

- I. Chairman Miller called the meeting to order at 7:03 p.m. at Oak Grove Mennonite Church.
- II. E.J. Snider gave the invocation.
- III. Proof of notice of the meeting was acknowledged by all present.
- IV. Minutes of the January 08, 2018 Annual Membership Meeting were read by the secretary Curt Stutzman. A motion to approve the minutes as read was made by Don Peper. Ruth Miller seconded the motion and it was passed unanimously by the members.
- V. CPA Ronnie Bowers of Hood and Associates independent auditors gave the audit report of the District's finances as of September 30, 2018. A motion to accept the report as given was made by Glen Hamill seconded by Betty Hamill and passed unanimously by the members.
- VI. Chairman Miller introduced the Board members and employees.  - For term expiring held by *James Armontrout* Ruth Miller nominated *James Armontrout*. Don Peper seconded the motion and moved that the nominations cease and *James Armontrout* be elected by acclamation. The motion was passed by unanimous vote of the members.
 - For term expiring held by *E. J. Snider* Melvin Voth nominated *E. J. Snider*. Ruth Miller seconded the motion and moved that the nominations cease and *E. J. Snider* be elected by acclamation. The motion was passed by unanimous vote of the members.
 - For the fulfillment of the term vacated by George Peper's retirement and currently held by appointee Blake *Peper* Ruth Miller nominated *Blake Peper*. Allen Peper seconded the motion and moved that the nominations cease and *Blake Peper* be elected by acclamation. The motion was passed by unanimous vote of the members.

Next item was to draw for 10 prizes of one month free minimum water bill. There were only 10 members signed up for the drawing so all 10 received a free \$20 minimum. The members receiving minimums are as listed.
